Minutes / Agenda

Discussion on the Council Moving Forward

Mike Scuderi will contact Tracy Taylor, the Neighborhood Coordinator for the City of Kent to seek counsel and advice on this decision and possibilities for moving forward. The Council will maintain its official charter and financial assets and accountability for those. The Council will continue to host the website and to keep members informed via Facebook and NextDoor.

The Council will continue its communication with FWPS and the City of Kent Parks and Recreation related to our support of **development of the playfield at Evergreen Middle School**. Mike will find the notes/action plan from the Parks Department stating that the playfield is on their radar and Holly will contact Michael Swartz to make sure that this communication/request stays in their project action plan.
