Madam Mayor,

On behalf of the West Hill Cambridge Neighborhood Council, we extend our thanks to you and your staff for always being willing to share your insights and hear our concerns. Our annual meeting was well attended; I assume it was because you were there.

As promised, allow us to share those concerns and requests shared by members of our neighborhood at this meeting:

- Large request from neighbors along S 262nd Street relative to excessive speed (there were five households in attendance along with a signed report/request for revision/petition listing 15 residents which I will append to this letter). I travel that route all the time and concur that this strip is for some reason prone to picking up speed; this continues then up the hill onto 46th Ave/Carnaby. I suspect a speed bump or two on 262nd could help but may divert traffic to a right hand turn on 43rd Ave S then turning left at S. 263rd which is another neighborhood filled with children.*
- Abandoned and disabled vehicles parked on streets and in yards are commonplace and deemed a
 nuisance by neighbors. There is a question about where responsibility lies within the city to make contact
 with owners for proper handling and/or disposal. (collective report to follow)
- Derelict properties, likewise
- The intersection at S 264th, 34th Ave & Hampton Way is an unregulated multi-directional problem that could use a study on controlling flow.
- Request for lane management/revision/clarification on Military Road S at S 268th (noting turn lane confusion) This was created with the addition of that new housing tract south of St. Columba's Church.*
- Glenn Nelson Park noise control, night lighting and vagrancy in the wooded area on the north end of the park, east of the fire station. Most WHCNC discussion over the years has concluded that the parks are a treasure to the neighborhoods and valued by families and walkers.*
- S 272nd corridor during rush hour and during Islamic Center service release (two separate issues). *Kent Police used to create deterrents by parking off the side of the road westbound at about 36th Ave; just this sight caused speed caution.**
- Zoning/road safety along Military and Reith Road/S 259th/S 260th (from West Fenwick Park all the way to Pacific Hiway S). I believe this is a collective set of issues: parking at the park; light rail construction impact on road safety (lines very difficult to see especially at night); derelict green belt area behind the old Albertson's and impact on wetlands as well as local businesses; dark crosswalk and poor lighting at that same area.*

As you know, the neighbors here are fully vested in creating the safest neighborhood possible and welcome your support and remedies for these safety concerns.

Again, thank you for your kind consideration and support for what is best for the West Hill of Kent.
